
Please allow this letter to provide members updated information regarding the active run off of the NYT Trust.

#### **TRUST DOCUMENT AMENDED:**

There are a percentage of members who are not paying the assessment and therefore collection referrals have become necessary. The NYT Board of Trustees met and approved the following resolution. The resolution has also been approved by the Workers' Compensation Board.

\*\*In accordance with Section 6.01 of the Amended and Restated Trust Agreement of the NY Transportation Workers' Compensation Trust dated effective July 1, 2007, as amended by Amendment No. 1 on September 17, 2008 (collectively, the Trust Agreement"), which authorizes the Trustees to amend the Trust Agreement with the consent and approval of the Workers' Compensation Board if the duties and responsibilities of the Participating Members is not materially increased thereby, the Trustees hereby unanimously consent to amend the Trust Agreement to allow the Trust to engage a law firm, a collection agency, and/or other professional service providers to collect overdue contributions and other amounts due and owing from Members to the Trust, including, but not limited to interest and costs of collection. A copy of the Amendment along with the Trust Agreement is located on the NY Transportation website.\*\*
